



## TCSO AND US MARSHALS ARREST ROBBERY SUSPECTS

With the assistance of the US Marshals, TCSO has arrested two suspects in connection with last Saturday's armed robbery of the "The Fast Stop" convenience store at 1502 N Yale.

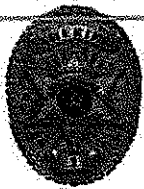
Yesterday Brianna Thomas was arrested at 12304 East Archer St for robbery with a dangerous weapon and unauthorized use of a motor vehicle. Thomas is accused of taking an acquaintance's car without permission and driving Jesus Mendoza to the store where the robbery took place. Investigators believe Mendoza is the man pictured in the surveillance video of the robbery.

Later in the day Jesus Delano Mendoza was arrested after a standoff with TCSO and US Marshals at 2002 N Atlanta Place. After about an hour of negotiation, he was taken into custody. Mendoza was arrested for Robbery with a Fireman and Obstruction of an Officer.

Detectives say this case was solved based on numerous tips they received after photos of the robbery were shared by local media outlets.

Probable Cause Narrative

On 4/27/17 at approximately 1940 hours Deputies and U.S. Marshals attempted to serve a felony arrest warrant for Robbery with a Dangerous Weapon at 2002 N. Atlanta Place on Jesus Mendoza. Several individuals told Deputies and Marshals that Jesus Mendoza was in the residence and was seen with a firearm earlier in the day. Utilizing the P.A. system the residents were asked to exit the residence. Multiple individuals exited without incident. Jesus Mendoza failed to follow these verbal orders and remained inside the residence. U.S. Marshals were able to break a window to the residence a spray pepper gas into the residence. After approximately 15-30 minutes with no contact Jesus Mendoza finally acknowledged Deputies by opening the front door to the residence. Jesus Mendoza opened the front door to the residence and stated that someone had a gun to his head. Jesus Mendoza was then seen holding a knife stating he was just going to kill himself.
