This data analysis extends from January 1<sup>st</sup> through December 31<sup>st</sup> of 2017. I am pleased to report there were 49 allegations and investigated events. In comparison to 2016 there were 30. Also in 2017, there were 4 substantiated allegations (up 2), 17 unsubstantiated allegations (up 2), and 26 unfounded allegations (up 13). These increases are in line with our goal of increasing awareness and reporting during the 2017 year.

There appear to be no significant problem areas. Corrective actions to individual problem areas are ongoing. The inmate's names were redacted to protect the safety and security of the reporting inmates, other inmates, and the security of the facility as a whole.

Corrective action was taken on an ongoing basis to the system as a whole. The review teams provided valuable information on operational changes. The PREA system is progressing as expected. This year we completed another audit. The auditors made recommendations that were completed in May of 2018. The audit was a success. In 2018 we will strive to continue improved reporting, operational reviews, and additional training.

The Prison Rape Elimination Act (PREA) was passed in 2003 with unanimous support from both parties in Congress. The purpose of the Act was to “provide for the analysis of the incidence and effects of prison rape in Federal, State and Local institutions and to provide information, resources, recommendations and funding to protect individuals from prison rape.” This law applies to all public and private institutions that house adult or juvenile offenders.

The Tulsa County Sheriff’s Office is committed to a zero-tolerance standard towards all forms of sexual abuse and sexual harassment between employees, volunteers or contractors and offenders as well as inmate upon inmate sexual abuse or harassment.

How to report incidents of sexual assault or sexual abuse:

TCSO accepts and investigates reports regarding allegations or knowledge of sexual abuse of offenders from third parties including family, friends, clergy, vendors, contractors, or any other person having knowledge of an incident.
